## CAVEAT

The total awards for men's teams is significantly higher due to a larger percentage of non-resident (out of state) athletes on the men's teams. The reported aid includes a non-resident abatement of $\$ 5,340$ per semester per non-resident. This abatement brings the student's tuition rate down from $\$ 8,919$ to $\$ 3,579$, which is equivalent to the in-state rate. The majority of athletes on the women's teams receive the in-state rate and do not require an abatement award.

Recruiting expenses are all expenses an institution incurs attributable to recruiting activities.
