ACADEMIC COUNCIL

The Academic Council, chaired by the Dean and co-chaired by the Senior Associate Dean for Academic Affairs and Diversity, meets monthly and is composed of all academic department Vice Chairs, the Biomedical Sciences Department Chair, the GHS Chief Nursing Officer, President of the GMH campus, GHS Vice President for Faculty and Academic Affairs, a resident/fellow representative, and the Executive Director for Finance and Administration. The Academic Council is the primary coordinating body for academic resource allocation and the clinical learning environment. This Council is advisory to the Resource Council and serves all academic programs/governing bodies at the GHS Clinical University.

The Academic Council provides strategic direction for the School of Medicine, including the promotion of interdisciplinary educational and research activity, and will have regularly scheduled monthly meetings. Department Chairs provide a report regarding their departmental faculty activities and chairs of standing committees will regularly report their activities to the Academic Council to promote awareness of the work of the committees.

The Academic Council has been established by the health system for leadership and oversight for the clinical learning environment. The Council also serves as the Academic Council for the Medical School. The Academic Council is responsible for the clinical learning environment that includes six domains (patient safety, duty hour of faculty and trainees, hand-offs, quality improvement, supervision of trainees and professionalism). The following 4 subcommittees have been established to ensure a vibrant learning environment for the Medical School:

- 1. Patient Safety/Quality
- 2. Professionalism/Supervision
- 3. Transition of care/Work hours
- 4. Resource Budget

Additionally, the Dean has direct access to resources of the GHS Clinical University education, research and clinical programs. These resources are strategically designed to ensure the success of the Medical Schools' educational, research/scholarship and clinical goals are accomplished. The Medical School leverages the institutional academic resources of the parent university and the clinical partner's healthcare expertise to demonstrate a robust continuum of resources across all four years of the Medical School.

This committee is appointed for 3 years and meets every 3rd Thursday of the month.
