# **Recent and Upcoming Events Overview**

On October 9<sup>th</sup>, the ASC hosted a conversation on artificial intelligence technologies' place in the university that featured faculty from across the academic divisions. The provocative and generative discussion drew 24 attendees, while the video of the discussion has been viewed 28 times on our YouTube channel. On October 19<sup>th</sup>, the ASC participated in the Olde English Consortium's Junior Scholars day, hosting over 70 high school juniors from the Consortium's 7-county service area. Two of our peer tutors, Claire Stone and Zoe Bowers, presented a workshop on study skills and answered student questions about choosing a college and adapting to college life.

We are experiencing unexplained difficulties with our automatic tutoring reports. If you typically receive these, please take a moment to verify that you are receiving them as we work to correct the issue.

# **Summary of Tutoring Data**

**Year-to-year trends:** the data reflect what we knew anecdotally: the center has experienced an explosive rise in demand, more than doubling the number of sessions in October 2022. This is driven by growth across all formats, but also by two well-attended review sessions offered through our Health Sciences Studio service. The students-served data suggests we are seeing a higher proportion of repeat clients, which we will take into account as we near our current service capacity.

Session distribution trends: Students continued to prefer in-person sessions by a wide margin in October. We also saw increased demand for all of our studio services. Students this semester seem to value this style of drop-in assistance more than they did in the past, though we are still monitoring attendance numbers to ensure their long-term viability. The ration of virtual to in-person appointments remained relatively steady compared to prior months.





In addition, we will be closed on Monday January 1, 2024 in recognition of New Year's Day. Campus will officially reopen on Tuesday January 2, 2024.

Faculty and FTE Staff are not required to make any submission on their timesheets in reference to the holidays.

#### **Columbia Faculty Senate 10-4-23**

Meeting notes are not verbatim and have the general tenor of content covered (see future posted recording for exact specifics).

#### **Provost/President Report:**

- The president of the university could not be in attendance as they are meeting with donors and the university committee throughout this week. The provost gave a short update on the Bridge to Faculty program. The plan is to have 12 positions/hires and 6 of the have been filled. Currently, 23 departments have submitted applications and are currently under review.
- Columbia is currently testing out an app called Circle-In (I believe that is its name) that utilizes a social media-like platform for students to engage with each other as well as TAs. The goal of this is to help build a sense of community in courses that have high DFW rates. The current classes are Accounting and Calculus. These classes were picked given the DFW rate as well as the high enrollment. Currently, USC is the number one university in usage of the app, which is a NSF project. Currently there are almost 1200 users and over 7000 flashcards made. Students are currently using it for direct messaging, homework issues, thanks each other, and it seems to be creating a culture of appreciation. From the faculty side of things, they find it useful by getting feedback from students. How were these classes selected? Large courses and DFW rate and pay to be part of the NSF study.
- Additional points were:
  - Teaching evaluation response rate for the university is at 23% these play a key role in T&P and thus we want to have more than less. Currently there are discussions of and having focus groups for what platforms are best, be it paper, electronic, in-class, outside of class, as well as what barriers exist (i.e. too many questions, too many evaluations, some sort of incentive to complete them, and so on).
- Lastly, the first year reading program is reevaluating and is the process of beginning to meet with a combination of student and faculty, looking for best practices and how to create a better experience.

# **Curricula and Courses Committee Report:**

- Of importance is that if one is planning on having a new course in the fall that needs approval it should be submitted by October 25<sup>th</sup>.
- The committee reviewed 45 new proposals and there was a discussion of the three certificates (i.e. Data Visualization, Project Leadership and Management, and Strategic Thinking). The discussion centered on how the current process to get a course approved does not seem to apply to certificates and that these are housed under Interdisciplinary Studies. The system/process may need to be looked at and reviewed to make sure it is functional and works for all options and the home for these may not fit with the current language/system. The committee did not discuss this issue and a representative of Interdisciplinary Studies Committee was on hand to address the question/concern. They provide guidance to the provost and had

representation from each college and went course by course to design the certificates. This process has been used in the past and was utilized here and was not just created for these certificates.

• The motion to approve the 45 proposals passed.

#### **Faculty Advisor Committee Report:**

 The committee presented a motion to adjust the language to the Graduate Council specifying composition as well as including a provision that colleges with 400+ graduate students had greater representation. The proposed change does not alter the function of the council. This motion will be voted on in the November meeting.

#### **Scholastics Standards and Petitions Report:**

 The committee wanted to offer and present some changes to clarify language focusing on grade forgiveness and how the wording at Columbia and the regional campuses differs/policies are not the same. Additionally, the change in language is also to allow for greater clarity for Dual Enrolled students. The proposed changes will be posted on the faculty senate's website shortly. A vote will happen in the November meeting.

#### **Admissions Committee Report:**

- The committee reported two motions
  - The first motion was to keep the Test optional admissions (thus not requiring students to submit SAT/ACT scores). The current policy of test optional was enacted during the pandemic and had a lifespan until 2023. Non-tested students preformed as well if not better than those who did submit SAT/ACT scores. The motion is to keep the test optional policy for the foreseeable future and or until the committee sees a need to change/adjust this practice. The motion passed after the following discussion.
    - Discussion ensued and focused on whether this affects those who could benefit from submitting them, scholarship both university and state, and what the benefit of this optional stance is. The response was that that this does not affect admission, students are reviewed holistically and this can be one part but not the only part under consideration. Keeping USC test optional keeps us competitive as most other schools have adopted and marinated this practice, thus a change back would put us at a disadvantage. As for scholarships some require them and others do not. If required the student is informed.
  - The second motion was to update policy that has become outdated. Currently schools outside the US have AP like tests that can count for college credit (i.e., A-level exams) and some high schools in the US are offering similar tests. The change to the policy is to have the main accreditation body's (AUFQUAL?) accepted/approved examination boards to be accepted. Currently only Cambridge international is accepted by USC. The change would allow others to be accepted Oxford AQ and Pearson EdExcel (this is how I heard them) as they also offer a standard set of exams. The motion passed after the following discussion:

The main question was what is the possible impact of accepting these others and sort of having a blanket approval of any approved examination boards. The response was that this sets a higher standard as the accreditation body is more stringent and there are some less than reputable examination boards. Thus USC will be in a position to accept qualified exams and not suspect ones.

#### **Secretary of Faculty Senate Report:**

 The main focus was just to let everyone know that the position is still open for the following academic year.

#### Old business:

• There should have been a report from the professional track faculty committee last meeting about the status of their revisions to the faculty manual language. The committee had a representative and said they are still reviewing and revising the language. A few questions were asked, such as the breakdown of the committee's membership, which was not known at the moment. It was also asked if there was a justification document for these changes to the language. It was suggested that yes there will be some sort of document, but nothing clear at the moment. There was also brief discussion of how changes in title can impact the guidelines for promotion.

#### **Bookstore Committee Report:**

- The main focus was the First Day Complete Program which is a textbook program like the one we have at Lancaster. Students would be charged a fee of \$20 per credit hour. Currently, they are conducting and reviewing focus group data on the proposed change. It is an opt out policy with Barnes n Noble, where one is automatically opted in. All textbooks will be rentals. It is also an all-in or not for students. And thus they may pay the cost of book even if the classes doesn't have a text.
  - Several questions came up that focused on the following:

- What is the typical cost of students now compared to this? Is there any consideration that it is prohibitive?
- It should be an opt in format rather than opt out, which seems a bit unethical given how students do not check or see emails.
- Concerns about having access to online platforms and or having to pay twice the price for homework suites.
- Does this flat fee only apply to classes at the undergrad or are graduate students also paying this textbook fee for course work like thesis hours?
- When and how do students know what their textbooks cost if they don't know until after they have paid their fees.
- How does this program impact scholarships?
- Many of the questions went unanswered and were going to be asked of the Barnes and Noble representative who will be at the next meeting.

#### **New Business:**

- The discussion and information first focused on a motion to change faculty senate meeting rules to allow for meeting dates to be changed without senate approval in order to work around holidays and other possible conflicts. The new language will specify that there isn't a need to have a full faculty vote and can be made by the chair etc.
- There was a short report of a new committee to review and decide on possible future Learning Management System for the USC system. The committee will start its work soon and provide feedback and direction on a possible choice. There seems to be only 1 Palmetto college representative. Thus I wonder if this does not apply to us as regional campuses, but would like to have more information and the representation currently does not seem equitable. A vote will take place in November for listed positions and member-elects.
- A general comment was made about how breaks have been kind of off and unbalanced.
   Meaning a short winter break and long summer and so on given the later start in the fall and the
   early start in spring. The response was that the academic calendar is on a seven year cycle and
   thus given how dates fall the byproduct is some late/early starts. The administration is currently
   looking into this and colleting ideas of what can be done.
- Lastly the first AAUP meeting is to be held on 10-25-23 4-5pm via Zoom link will be on the USC chapter of AAUP's web page and all are encouraged to attend.



- In 2017, the Council for Opportunity in Education (COE) and the NASPA Center for First-Generation Student Success partnered to launch a nationwide First-Generation College Celebration Day. November 8<sup>th</sup> was selected as the annual date for this celebration to coincide with the anniversary of the signing of the Higher Education Act (HEA) of 1965. A bipartisan resolution, led by Senators Marshall (R-KS) and Warnock (D-GA), was passed unanimously recognizing November 8<sup>th</sup> as a day to recognize the accomplishments and contributions of first-generation college students.
- USCL will hold its **3rd Annual First-Generation College Celebration** on Wednesday, November 8. We plan to have at least one food truck on campus for lunch from 11:00 a.m. to 2:00 p.m. Our very own **Antonio Mackey** will serve as music DJ, and we will be filming testimonials from first-gen faculty, staff, and students throughout the day.

#### **Upward Bound**

- Our Upward Bound project is in year two of a five-year grant cycle which will conclude on May 31, 2027. We are currently serving 38 students from first-generation and low-income backgrounds at **Andrew Jackson**, **Buford**, and **Lancaster High Schools**. We must increase our official enrollment to a minimum of 62 by the end of the current reporting period on May 31, 2024. We are working diligently to review an additional 55 pending applications. This puts us in good shape to reach our target enrollment.
- We held a Financial Aid Workshop on October 24. Many thanks to Ken Cole and Tyrie Rowell for presenting to our participants.
- **Eddie Boykin** and **Aundre Vinson** made multiple visits to Andrew Jackson and Lancaster High Schools last month. Key contacts have been made with the administration and counselors. We are planning a site visit to Buford High School later this month.
- Participants will be visiting Coastal Carolina University in Conway, SC on Tuesday, November 7.
- Qualifying students are allowed to receive monetary stipends for their participation in the project. We are in the process of finalizing these payments for the 2022-23 academic year.
- We appreciate Eddie Boykin for representing us at the South Carolina TRiO Association's (SC TRiO) Fall Conference in Columbia on November 3. Eddie will be moderating a session on "The Impact of Mental Health in Professional Environments."

- The APR for Upward Bound will measure the following objectives: (1) percentage of participants who have earned a 2.5 GPA or above; (2) percentage of participants who have achieved at the proficient level on state assessments in language arts and math; (3) retention and graduation rates; (4) secondary school graduation rates via a rigorous program of study; (5) postsecondary enrollment rates; and (6) postsecondary completion rates.
