USC Palmetto College Faculty Senate Meeting November 8, 2019

Elkins Report

My report today includes six brief items:

1. First, I'm delighted to share the very positive news on Fall Semester 2019 enrollment. The final census date was October 24, and the Palmetto College overall headcount enrollment for the campuses is up from the final day last year by 464, or 9.97%, (from 4,653 to 5,117) and FTE enrollment is up by 89, 2.78%, (from 3,204 to 3,293) over Fall Semester 2018, again resulting in the largest percentage increases of all the USC campuses. For comparison, the overall USC System increase is 1.91% in Headcount and 0.97% in FTE. The official Institutional Research report for October 25th is attached.

In addition to the associate's degree enrollment, the Palmetto College Online completion degree headcount enrollment as October 25 was 1,120 compared to a final headcount last fall of 1,071, for a 4.58% increase. Palmetto College Online has also graduated 1,587 students as of Summer Semester 2019.

Also, we have reached three very significant milestones this semester! Number one is that this is the first time since the launch of Palmetto College in Fall 2013 that we have exceeded 6,000 in the overall enrollment of Palmetto College, with a headcount of 6,355 as of the freeze on October 25. Second, this is the first year that the overall enrollment of the regional Palmetto College campuses has exceeded 5,000, with a headcount enrollment of 5,117 on the freeze date of October 25. Finally, this is the first time that Palmetto College Online headcount enrollment has exceed 1,100, with 1,120 on October 25. The Palmetto College Enrollment Trends 2008-2019 is attached, so congratulations to everyone involved in reaching these three very significant milestones in the overall enrollment of Palmetto College!

Second, an item I failed to mention in my last report is that we are all so pleased that all four of our regional Palmetto College campuses were ranked in the top five two-year campuses in the state in the NICHE 2020 Best Colleges report, with USC Lancaster being ranked #1 in South Carolina and #2 in the Nation, USC Sumter being ranked #2 in South Carolina and #5 in the Nation, USC Salkehatchie being ranked #3 in South Carolina, and USC Union being ranked #5 in South Carolina. This is an amazing accomplishment, and we're so very proud of each of our Palmetto College campuses!!

- 3. We are also pleased that President Bob Caslen and First Lady Shelly are visiting each of the campuses. As was noted at the last Senate meeting, they visited both the Allendale and Walterboro campuses of USC Salkehatchie and USC Sumter the day prior to the Senate meeting on September 26, the Union visit was October 30, the Lancaster visit is scheduled for November 20, and we're working on a date for a visit for Palmetto College Columbia. We will keep you updated as the visits occur, but I know we are all very pleased that the new President and First Lady are visiting all our campuses during their first semester here.
- 4. On the new website that includes all Palmetto College faculty by discipline that was demonstrated at the last meeting, please let us know if there is any additional feedback or other suggestions you might have after reviewing the new site. Again, we are very grateful to Bob Dyer, Bryce Mobley, and Victoria Hollins for their work in creating this new site that brings together all our faculty members by discipline as one Palmetto College faculty. - 5. Regarding the announcement about the library resources from the Thomas Cooper Library now being accessible to Palmetto College faculty, please let us know if you been hearing any feedback on whether this is working well or there are problems that need to be addressed.
- 6. Finally, for clarification purposes, as I announced at the last Senate meeting, we are thankful that funding for USC from the state legislature included a two percent salary increase for those who earn a base salary of less than \$100,000 and a \$600 bonus for those who earn a base salary of \$70,000 or less. We recently received an anonymous letter that stated concern over the raises being for those making over \$100,000 (instead of under), so we want to make sure that everyone understands that the raises are for those making less than \$100,000, not more than \$100,000.

In relation to that, the raises mentioned above have now been factored into the PC Campuses 2018-19 Salary Study and implementation of the recommendations is moving forward. The \$100,000 contribution will be dispersed at the beginning of the new year in January 2020. Information regarding the details of the study and the implementation plan will be distributed across Palmetto College before the December holiday break. We are pleased to begin addressing salaries of faculty and staff due to the enrollment and financial successes of the Palmetto College Campuses and Palmetto College Online.

In closing, again, thank you for all that you do in your leadership role on the Faculty Senate, as well as for all you do for your campuses and students every day!!!

Report to PCFS, November 08, 2019

Regular meetings have been ongoing with the SC CHE, CAAL, CAD, ACAP, APL, NOC, the Chancellor's Cabinet, and I still convene the Academic Deans. Jean Carrano keeps the agendas and meeting notes on file for each of these groups and you are welcome to see any of the above.

The course approval process for faculty is ongoing. With Dr. Cox's help we have made progress with the History Department. We still have issues in the English Department, but we are working on that. Suggestions are welcome. There are positives with the current approval process using the Columbia departments, including SACS accreditation issues and SC CHE program modification approvals.

I also play a small role in the PC SACS accreditation process, but David Hunter is usually the best source for any questions concerning accreditation.

The T&P process is moving along. We have 8 candidates for Tenure and Promotion to Associate Professor and 5 candidates for Promotion to Full Professor. All local committee members should now have access to the files. Jean Carrano does an amazing job keeping all this organized and on time.

John Catalano, USC Union Dean's Report to Faculty, November 22, 2019

Students

Enrollment for Fall 2019 is up. We now serve 1153 students from over 100 high schools, over 50 counties, and 10 states. In Fall 2015 that number was 575. This is the fourth year in a row that USC Union has set a Fall Semester enrollment record. The third privately owned and operated student housing site adjacent to campus is now open. International study plans for next spring break (Caribbean) and summer (France) are underway. The USC Union Partnership Board will meet in December. A rifle target team is new for the Fall. Both soccer and baseball will now play at new Bantams stadiums in Jonesville. NJCAA women's volleyball will be added in Fall 2020.

Faculty & Staff

We will hire new faculty in Biology and Nursing for Fall 2020. A current search is underway for a new student activities coordinator. Dr. Aziz is spearheading the reapplication for a federal OSP/TRIO grant for the campus.

Facilities

We have met with architects to develop final plans for the conversion of the old library space to classrooms and faculty offices, using the space primarily for language arts and humanities instruction. We should have the space ready by Fall 2020. We have begun to convert the old Post Office Building to a fine arts building, including classrooms and faculty offices. The corner building next to the Bookstore at 317 East Main St. will be the new USC Union Welcome Center, housing Admissions and Financial Aid. We have added a third PC classroom to Union and Laurens sites and upgraded the four older PC rooms this summer. This year we hope to renovate all restrooms in the CB & MB, including handicapped accessibility upgrades. Science and Nursing Building improvements are ongoing. Several grants, including a BC/BS grant of \$150K, have been awarded toward nursing simulation and nursing instruction. We also have received Mrs. Rippey's building at 125 East Main St. and a pledge of \$300K as a gift.

Budget

The USCU budget is in good shape, due mainly to recent enrollment increases, and both revenues and expenditures are very close to budgeted figures. We ended the fiscal year meeting our goal of maintaining a three-month reserve balance. SC continuing appropriations will get a bump this year thanks to Doug Gilliam's efforts in Columbia. USC Union has also seen some one time appropriations designed to renovate current facilities.

REPORT TO THE PALMETTO COLLEGE CAMPUSES FACULTY SENATE 08 November 2019 C.E.

I begin my report by expressing my thanks to USC Lancaster for its gracious hospitality in hosting today's gathering. It's always good to be able to visit my former stomping grounds in the Red Rose City.

I. Palmetto Pathway

- 53 students of the initial cohort of 54 are still enrolled in the program, and the vast majority (50) have already been advised or made appointments to be advised for their courses for SPRING 2020
- 14 different academic courses are scheduled for SPRING 2020, all of which meet at least one (sometimes more) of the Carolina Core outcomes
- Program requires students to complete 30 USC credit hours in the Fall & Spring semesters, and meet transfer (change of campus) requirements for their specific degree or program in order to matriculate fully to USC Columbia for Fall 2020; therefore we planning to schedule a limited number of online courses in early Summer 2020 for students who, for whatever reason, may need additional credits to meet the requirements (prior to July 01, which is the final deadline date for "change of campus" admission to USC Columbia for FALL 2020)

II. BLS/BOL

- Dr. Steve Lowe is leading our self-study of the Organizational Leadership degree (similar to the BLS process last year), which should conclude by early 2020 (and hopefully will actually be completed this fall)
- We currently have scheduled 47 different courses online and through two-way video for SPRING 2020 for students in the BLS & BOL programs

III. Lexington Transfer Center (LTC)

- We are conducting a survey of current BLS & BOL students who reside in the Lexington area to determine if there is need/demand for on-site courses at the LTC and, if so, what courses would be most useful to the students
- Other possibilities for the site include offering upper level foreign language courses for students in the area who have been in language emersion programs

IV. Fort Jackson

• Enrollment in the AA & AS programs remains relatively low but we are working with the Office of Military Programs & Strategies to improve visibility of (and accessibility to) the programs there for military students and their dependents

- Sixteen different courses (with multiple sections of many) are being offered at Fort Jackson in SPRING 2020, including ITEC 233 and ITEC 245
- We just completed a safety inspection of the science lab facilities at Fort Jackson and I'll be meeting with program director Brittney Vereen to discuss corrective (and proactive) measures based on the findings
- The SACS program prospectus for Fort Jackson will be submitted for initial review before we leave for the Thanksgiving break (approximately two weeks from now)

V. Miscellaneous

- I am also representing Palmetto College on the search committee for the University's new Vice President for Diversity and Inclusion. President Caslen has indicated that he wants this position, which is currently a Vice Provost position reporting to the Provost, elevated to a Vice Presidency, and has indicated that greater diversity will be a major goal of his administration. USC College of Nursing Dean Jeanette Andrews is chairing the committee. The committee is currently reviewing the proposed job description.






Lactation room
