Page 31: Applicants who are denied promotion and/or tenure will be notified by the President of the negative decision. Applicants who are denied promotion and/or tenure may appeal through the Palmetto College Chancellor for consideration on specific grounds (See Appendix IV).

Page 47: Only after following the procedure described above may the individual faculty member further grieve the matter by referring it to the Palmetto College Campuses Faculty Senate Grievance Committee (See Appendix IV).

Page 31: Applicants who are denied promotion and/or tenure will be notified by the President of the negative decision. Applicants who are denied promotion and/or tenure may appeal through the Palmetto College Chancellor for consideration on specific grounds. (See “Grievance Procedures for Palmetto College Campuses,” page 66.)

Page 47: Only after following the procedure described above may the individual faculty member further grieve the matter by referring it to the Palmetto College Campuses Faculty Senate Grievance Committee (See Page 66).
