#### Introduction

The Grants Operations Team supports College of Arts and Sciences (CAS) faculty and other researchers by managing the administrative aspects of their research grants. We provide resources, systems, and support so faculty can focus on conducting research and creating knowledge.




Data on proposals are sourced from the university's electronic research administration system, USCeRA.

One key goal in the CAS Blueprint for Academic Excellence FY2023-2024 is: *Increase extramural grant awards by 10%*. External funding year to date is \$41.5M – this is 35% more than external funding awarded at this time last year.

The University Electronic Research Administration (USCeRA) system is the university's primary tool for proposal and award administration. USCeRA allows us to track proposal submission trends.


